**Advisory Opinion No. 2020-01**

**Requested by Michelle Eubanks, Member, Florence City Council, Florence, Alabama**

Director Albritton explained the request for Advisory Opinion No. 2020-01. ***Ms. Brady moved to adopt Advisory Opinion No. 2020-01 as written. Mr. McDonald seconded the motion. Motion passed unanimously with all those present voting. Opinion No. 2020-01 holds that a member of the City Council of the City of Florence, Alabama may vote on, attempt to influence or otherwise participate in legislation affecting her public employer, the University of North Alabama, provided the legislation itself does not present a conflict of interest, as defined in the Ethics Act, for the public official.***

**Advisory Opinion No. 2020-02**

**Requested by Ryan P. Robichaux, Bradley Arant Boult Cummings, LLP, Birmingham, Alabama**

Ms. Raulston explained the request for Advisory Opinion No. 2020-02. *Mr. Plunk moved to adopt Advisory Opinion No. 2020-02 as written. Chief Justice Stuart seconded the motion. Motion passed unanimously with all those present voting. Opinion No. 2020-02 holds that a public official may seek a position as a retired state employee for the Board of which he is a member if he resigns from the Board, does not and has not previously used his position as a Board member to create the opportunity for himself, does not use any confidential information he obtained while on the Board in his pursuit of the position, and does not seek to corruptly influence his former Board members in their official actions in order to secure the position.*


**Colbert County Democratic Executive Committee**

*Mr. Acosta explained the request for the Civil Penalty Appeal. Chief Justice Stuart moved to set aside the December 3, 2019, January 3, 2020, and February 4, 2020 penalties and offenses. Mr. Plunk seconded the motion. Motion passed unanimously with all those present voting.*

**Adjournment**

*There being no further business, at 2:01 p.m. Mr. Plunk moved that the meeting be adjourned, and Ms. Brady seconded the motion. Motion passed unanimously with all those present voting.*
