Advisory Opinion No. 2025-01

Requested by Ken Hamilton

Mr. Paterson explained the request for Advisory Opinion No. 2025-01. Mr. Pappas moved to adopt Advisory Opinion No. 2025-01 as written. Mr. Dodd seconded the motion. Motion passed 3-0 with all those present voting. Opinion No. 2025-01 holds that a member of a town council who serves as an uncompensated, volunteer firefighter may vote on, attempt to influence, or otherwise participate in legislation before the Council affecting the volunteer fire department provided neither he, his family members, nor a business with which he is associated would uniquely benefit from his vote.

Zane "Buddy" Snipes, Board Chairman, Montgomery County Board of Registrars

Mr. Dodd moved that based on the evidence as presented to this Commission, there exists cause to hold that Zane "Buddy" Snipes has committed a minor violation of the Alabama Ethics Act, and further moved that this case be handled administratively and referred for review and appropriate legal action to the District Attorney of the appropriate Judicial Circuit. Mr. Dodd moved that on <u>August 7, 2024</u>, the Alabama Ethics Commission unanimously found Danielle Smith, Curriculum Specialist, Mobile County Public Schools, had committed one (1) minor violation of the Alabama Ethics Act and approved an administrative resolution at the request of the Respondent. The Commission forwarded the case to the District Attorney of the 13th Judicial Circuit who approved the administrative resolution on November 19, 2024. Accordingly, I hereby move as follows: 1) An administrative penalty in the amount of \$25.00 be ordered by the Commission to be paid to the Ethics Commission by cashier's check, money order, or online payment on or before April 2, 2025; 2) There is no restitution owing for this minor violation. Mr. Pappas seconded the motion. Motion passed 3-0 with all those present voting.

Elijah Bell, Technology Coordinator, Sumter County Board of Education

Mr. Pappas moved that on <u>December 4, 2024</u>, the Alabama Ethics Commission unanimously found Elijah Bell, Technology Coordinator, Sumter County Board of Education, had committed one (1) minor violation of the Alabama Ethics Act and approved an administrative resolution at the request of the Respondent. The Commission forwarded the case to the District Attorney of the 17th Judicial Circuit who approved the administrative resolution on January 3, 2025. Accordingly, I hereby move as follows: 1) An administrative penalty in the amount of \$2,500.00 be ordered by the Commission to be paid to the Ethics Commission by cashier's check, money order, or online payment on or before June 4, 2025; 2) Restitution in the amount of \$2,396.80 be ordered to be paid to the Ethics Commission by cashier's check, money order, or online payment on or before June 4, 2025 and disbursed to Sumter County Board of Education thereafter. Mr. Dodd seconded the motion. Motion passed 3-0 with all those present voting.

Case No. 2024-0051

Krystine Roberts, Teacher, Madison City Schools

Mr. Dodd moved that on <u>December 4, 2024</u>, the Alabama Ethics Commission unanimously found Krystine Roberts, Teacher, Madison City Schools, had committed one (1) minor violation of the Alabama Ethics Act and approved an administrative resolution at the request of the Respondent. The Commission forwarded the case to the District Attorney of the 23rd Judicial Circuit who approved the administrative resolution on January 7, 2025. Accordingly, I hereby move as follows: 1) An administrative penalty in the amount of \$100.00 be ordered by the Commission to be paid to the Ethics Commission by cashier's check, money order, or online payment on or before April 2, 2025; 2) There is no restitution owing for this minor violation. General Crowell seconded the motion. Motion passed 3-0 with all those present voting.

Mattalia Davis, Sales Associate I, Alcoholic Beverage Control Board

Mr. Pappas moved that on <u>December 4, 2024</u>, the Alabama Ethics Commission unanimously found Mattalia Davis, Sales Associate I, Alcoholic Beverage Control Board, had committed one (1) minor violation of the Alabama Ethics Act and approved an administrative resolution at the request of the Respondent. The Commission forwarded the case to the District Attorney of the 15th Judicial Circuit who approved the administrative resolution on January 23, 2025. Accordingly, I hereby move as follows: 1) An administrative penalty in the amount of \$250.00 be ordered by the Commission to be paid to the Ethics Commission by cashier's check, money order, or online payment on or before April 2, 2025; 2) Restitution in the amount of \$28.00 be ordered to be paid to the Ethics Commission by cashier's check, money order, or online payment on or before April 2, 2025 and disbursed to Alabama Alcoholic Beverage Control Board thereafter. The Commission forwarded the case to the District Attorney of the 32nd Judicial Circuit who approved the administrative resolution on January 17, 2025. Accordingly, I hereby move as follows: 1) An administrative penalty in the amount of \$200.00 be ordered by the Commission to be paid to the Ethics Commission by cashier's check, money order, or online payment on or before April 2, 2025; 2) There is no restitution owing for this minor violation. Mr. Dodd seconded the motion. Motion passed 3-0 with all those present voting.

Case No. 2018-0396

Chuck Holloway, Street Department, City of Roanoke

Mr. Dodd moved that on <u>February 6, 2019</u>, the Alabama Ethics Commission unanimously found Chuck Holloway, Street Department, City of Roanoke, had committed one (1) minor violation of the Alabama Ethics Act and approved an administrative resolution at the request of the Respondent. The Commission forwarded the case to the District Attorney of the 5th Judicial Circuit who approved the administrative resolution on or before January 7, 2020. Accordingly, I hereby move as follows: 1) On February 5, 2020, an administrative penalty in the amount of \$1,000.00 was ordered by the Commission. The Commission hereby approves a payment plan with monthly installments in the amount of \$250.00 on the remaining balance of \$1,000.00, to be paid to the Ethics Commission by cashier's check, money order, or online payment on or before September 17, 2025. Mr. Pappas seconded the motion. Motion passed 3-0 with all those present voting.

Case No. 2023-0274

Crystal May, Assistant Director of Bessemer Office, Jefferson County DHR

Mr. Pappas moved that on <u>August 7, 2024</u>, the Alabama Ethics Commission unanimously found Crystal May, Assistant Director of Bessemer Office, Jefferson County DHR, had committed one (1) minor violation of the Alabama Ethics Act and approved an administrative resolution at the request of the Respondent. The Commission forwarded the case to the District Attorney of the 10^{th} Judicial Circuit / Bessemer Division who approved the administrative resolution on or before September 4, 2024. Accordingly, I hereby move as follows: 1) On October 2, 2024, an administrative penalty in the amount of \$500.00 was ordered by the Commission. The Commission hereby approves a payment plan with monthly installments in the amount of \$175.00 on the remaining balance of \$350.00, to be paid to the Ethics Commission by cashier's check, money order, or online payment on or before May 21, 2025. Mr. Dodd seconded the motion. Motion passed 3-0 with all those present voting.
